## IV. Safety Star and Quality Recognitions

Dr. Ron Clark began by noting VCUMC and CMH are in the window for The Joint Commission hospital accreditation survey and have completed a readiness survey. He also spoke about the Foundation for the Acceleration of Cellular Therapy reaccreditation survey for which we are awaiting results, as well as the Commission on Cancer reaccreditation achieved by VCU Health System. Dr. Clark noted that the CMS website for rankings of publicly reported quality could be found data at www.medicare.gov/compare-care/. Following the quality recognitions, Dr. Clark recognized Dr. Swank a MRICU (Medical Respiratory Intensive Care Unit) Fellow as a Safety Star for answering a Transfer Center Call for the patient did not meet the transfer criteria while VCUHS was on transfer restrictions. After detailed conversation with the physician, Dr. Swank provided recommendations and actions to treat the patient. The physician phoned back to inform Dr. Swank the patient was awake, responsive and being weaned from the ventilator and the vasopressors. "You saved my patient's life; he is alive because of you," were the words of gratitude expressed by the physician and the patient's family.
